Counterterrorism Cooperation: Obama vs Biden

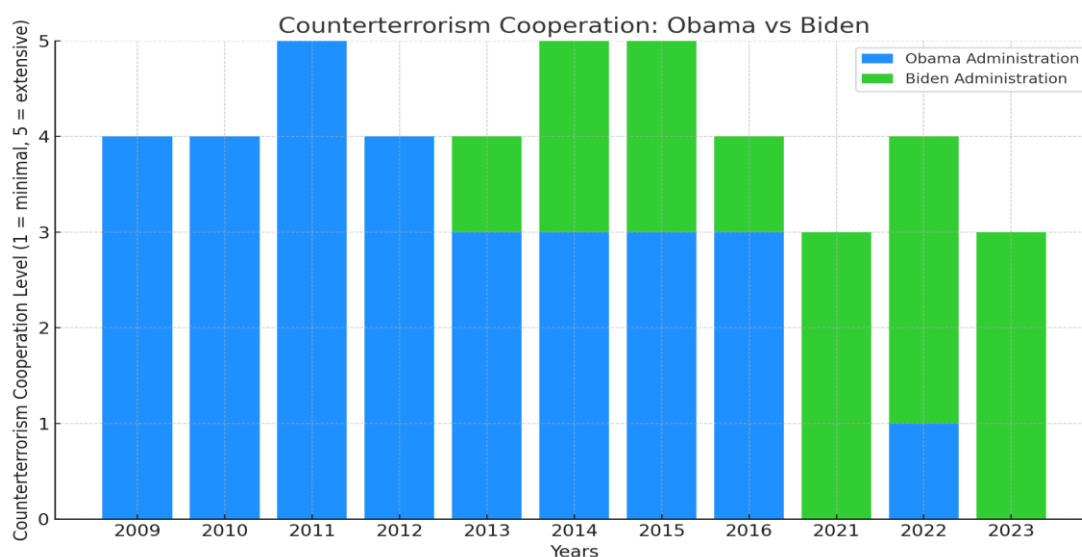

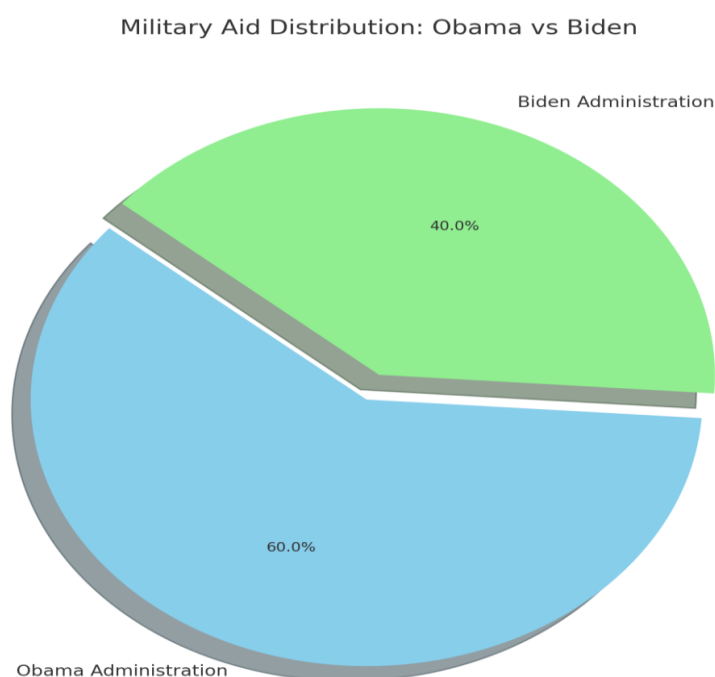

Figure 2 Military Aid Distribution: Obama vs Biden



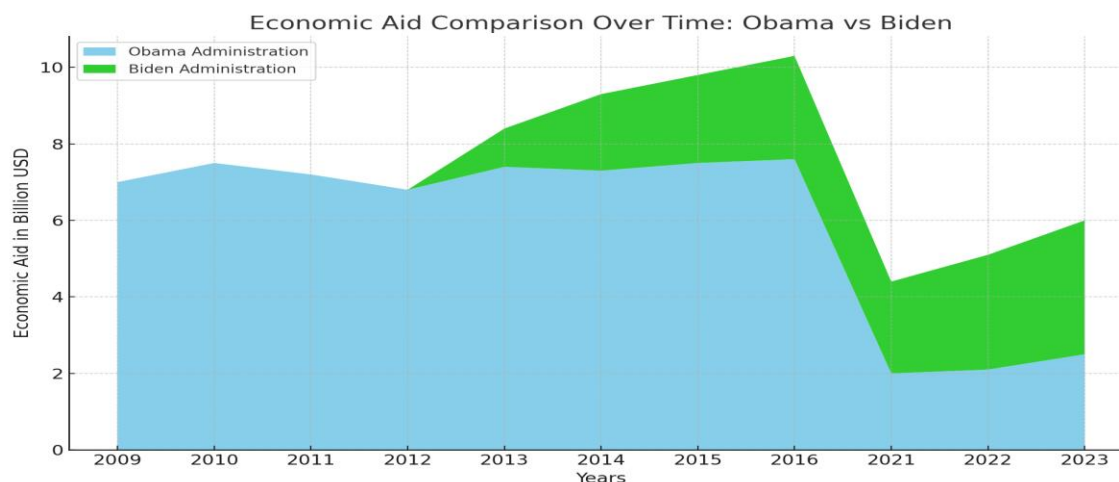

Figure 3 Economic Aid Comparison Over Time: Obama vs Biden



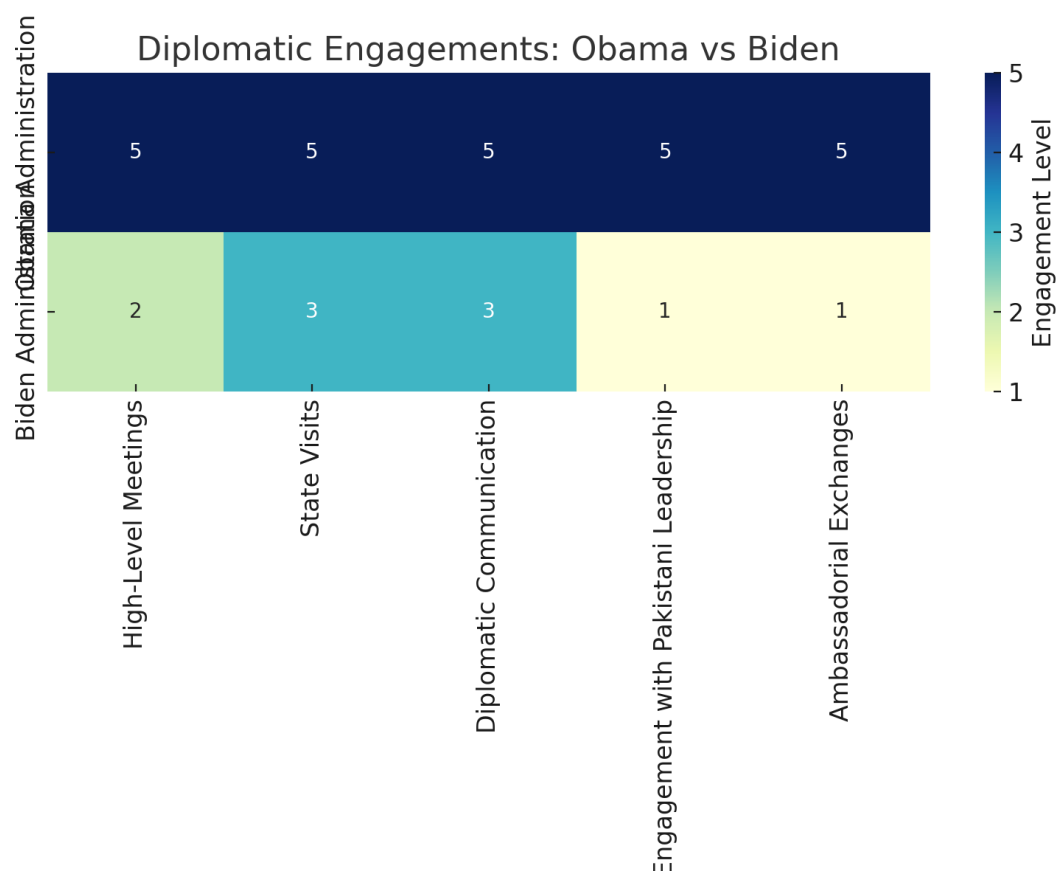

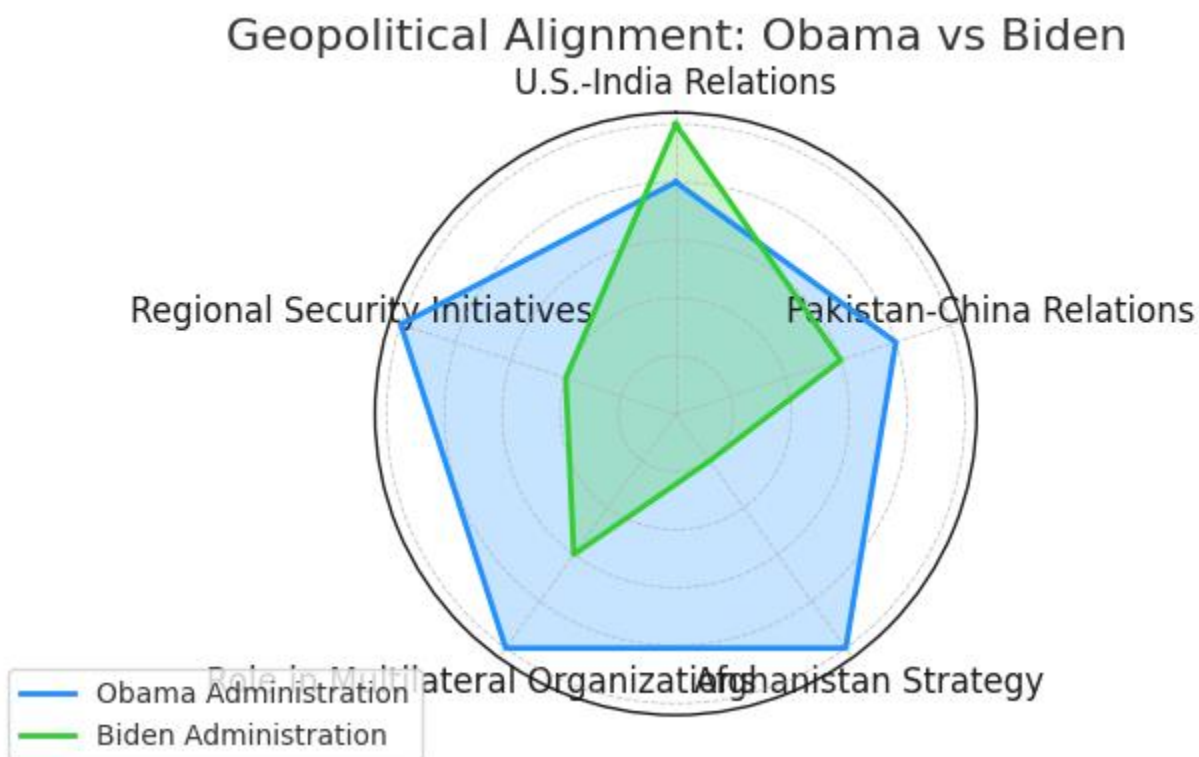

Figure 5 Geopolitical Alignment: Obama vs Biden



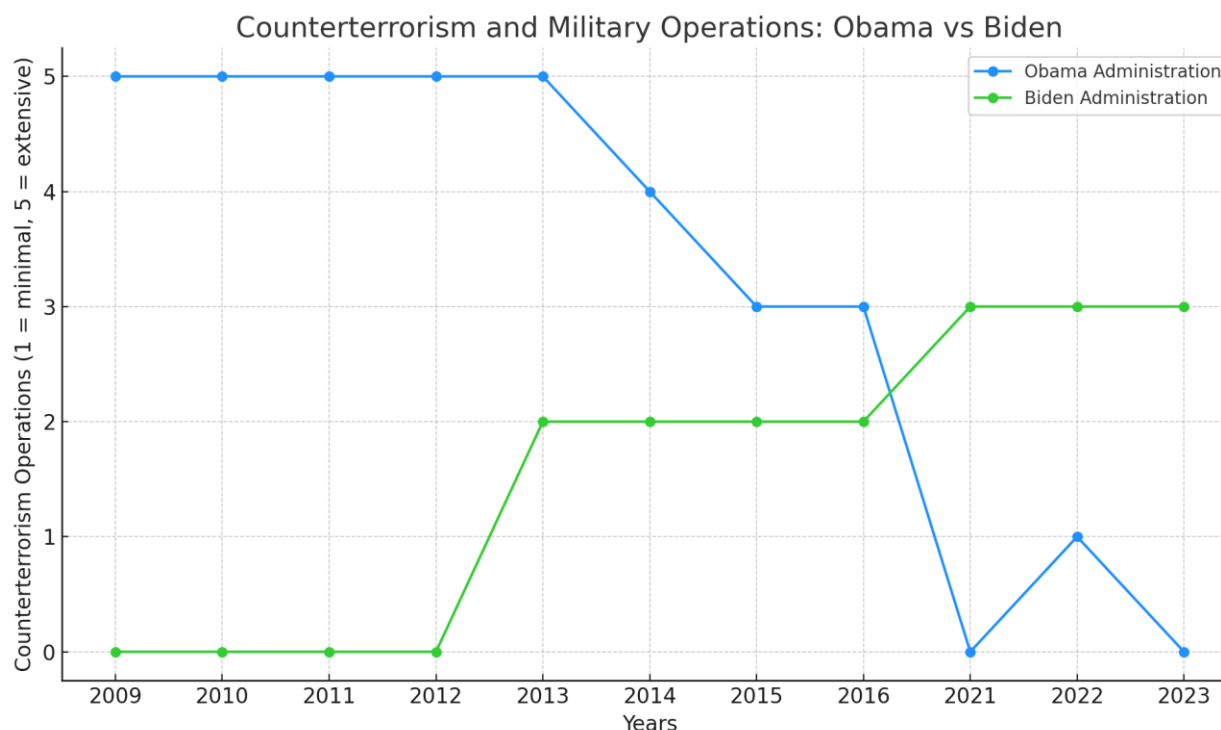
6. Counterterrorism and Military Operations: Obama vs Biden

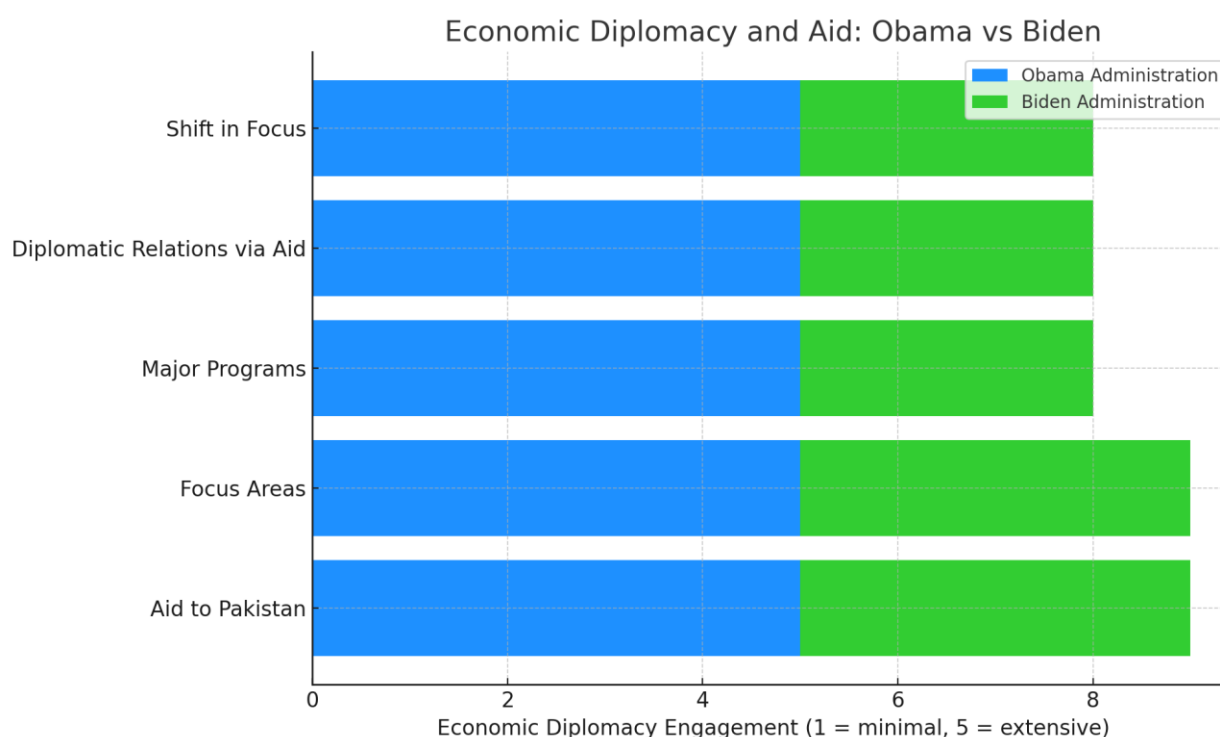

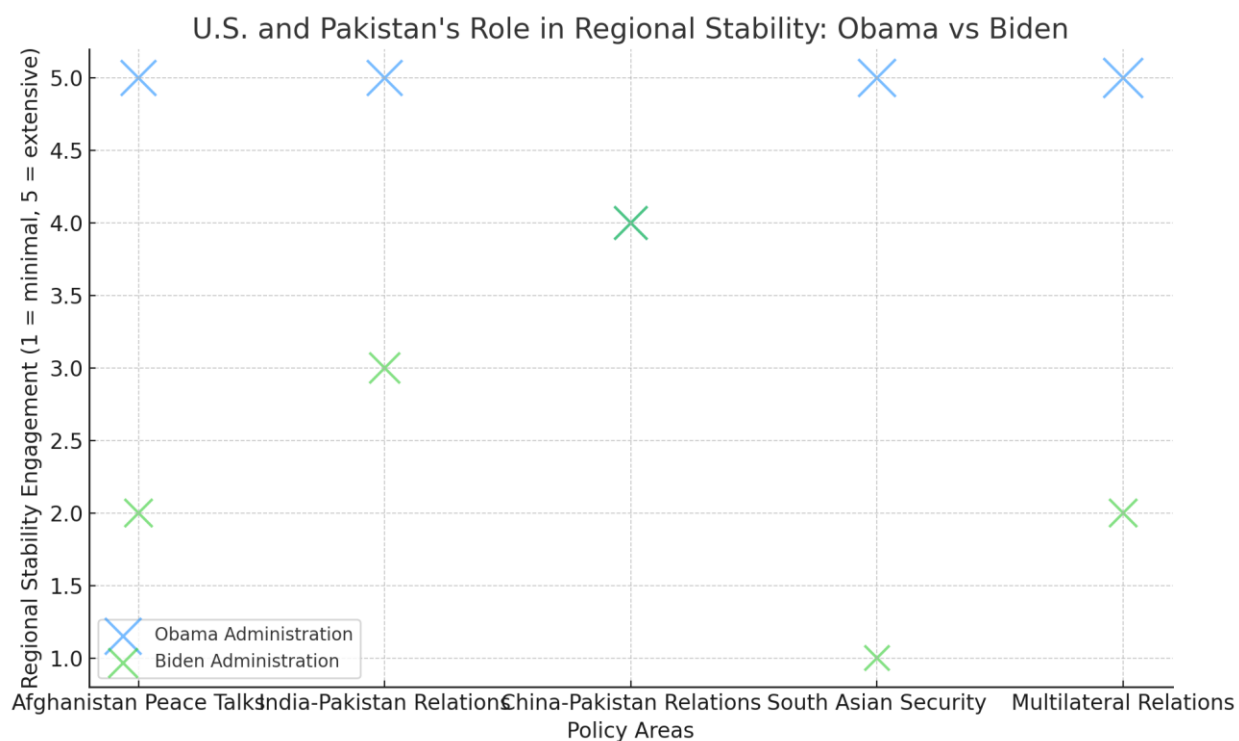
